- The sponsor of this contract agrees to compensate Blazin entertainment \$75.00 per hour for each additional hour, or any part of the hour over stated contract time.
- Blazin Entertainment reserves the right to postpone any jobs performed outdoors within (2) hours prior to the time of said engagement due to inclement weather conditions, Sponsor must provide shelter such as a tent from rain, or sunlight.
- The sponsor or representative of this contract must be at least 18 years old and warrants that he or she is authorized to execute this agreement
- All media i.e.; Video, photos and recorded audio from named event may be used for promotional purposes.
- If the sponsor cancels the contract, all monies paid to Blazin entertainment are surrendered to Blazin entertainment. If the contract date is changed, no penalty is charged.
- The sponsor of this agreement is responsible for any and all damage to equipment caused by any person or persons attending the above event.
- The same food and refreshments shall be provided to staff of Blazin entertainment while at the above event. (Applies only to events with food and refreshments)
- Assigned DJ's are not guaranteed, although we make every effort to support your requests.
- This agreement of Blazin entertainment shall be excused by detention of the DJ due to sickness, accidents, acts of god, or any other legitimate condition beyond the control of Blazin entertainment. In the unlikely event the DJ is unable to appear, Blazin entertainment will make every effort to find a qualified replacement. Should Blazin entertainment be unable to secure a replacement, client will receive a full refund less deposit. Further more, Blazin entertainments liability will be limited to the performance fee and will not be liable for indirect or consequential damages.

1. DJ(s) arrive at contracted location approximately one hour prior to contracted show time depending on distance, traffic, construction, etc. (Please provide directions to Blazin Entertainment during contracting).
2. All paperwork relating to your event i.e., Top 300 music list, wedding planner, invoice, etc., must be returned to this office no later the 2 weeks prior to contracted event date. (Music requests received after the two-week window cannot be guaranteed).
3. If contracting a 2 DJ wedding package, one of your DJ's may leave after formalities are performed to accommodate other scheduled events.
4. All checks are payable to Blazin Entertainment. If paying your balance on the night f the event, **NO CHECKS** will be accepted.
5. Blazin Entertainment has edited versions of most songs and takes all requests from your guests (within reasonable boundaries) you, the client choose your genre(s) of music.
6. Your date is not guaranteed unless you and Blazin Entertainment have a signed contract and a deposit is put down on the date.
7. Back-up equipment will be brought to all weddings and most private functions.
8. Contests/Trivia/Line dances and other activities come standard with our shows, if you do not wish to have these activities, please inform us during the contracting time.
